1.0 Policy:

This policy describes the determination process for coverage of specific drugs.

This policy does not guarantee or approve benefits. Coverage depends on the specific benefit plan. Drug Determination Policies are not recommendations for treatment and should not be used as treatment guidelines.

2.0 Background or Purpose:

Scenesse is a specialty drug indicated to increase pain free light exposure in adult patients with a history of phototoxic reactions from erythropoietic protoporphyria. These criteria were developed and implemented to ensure appropriate use for the intended diagnosis, if possible.

3.0 Clinical Determination Guidelines:

Document the following with chart notes:

A. Erythropoietic Protoporphyrin (EPP) [must meet all listed below]:

1. Age: at least 18 years.
2. Prescriber: dermatologist, gastroenterologist, hepatologist.
3. Diagnosis [must meet one listed below]:
 - a. Elevated metal-free erythropoietic protoporphyrin levels in peripheral erythrocytes (must be above 85 percent of total porphyrins).
 - b. Presence of loss of function mutation in the ferrochelatase (FECH) gene.
4. Dosage regimen and administration [must meet all listed below]:
 - a. Dosage regimen: Scenesse (afamelanotide) - 16mg implant once every two months.

- b. Must be administered by a healthcare professional proficient in the subcutaneous implantation procedure.
- c. Administering healthcare professional has completed requisite procedural training provided by product manufacturer.

5. Approval.

- a. Initial: six months.
- b. Re-approval: six months [must meet one listed below]:
 - Increase in pain free time during sun exposure.
 - Reduction in the number of phototoxic reactions from baseline.
 - Decrease in severity of phototoxic reactions from baseline.

B. X-Linked Protoporphyrinemia (XLP) [must meet all listed below]:

1. Age: at least 18 years.
2. Prescriber: dermatologist, gastroenterologist, hepatologist.
3. Diagnosis [must meet one listed below]:
 - a. Elevated metal-free erythropoietic protoporphyrin levels in peripheral erythrocytes (must be above 85 percent of total porphyrins).
 - b. Presence of loss of function mutation in the delta-aminolevulinic acid synthase (ALAS2) gene.
4. Dosage regimen and administration [must meet all listed below]:
 - a. Dosage regimen: Scenesse (afamelanotide) 6mg implant once every two months.
 - b. Must be administered by a healthcare professional proficient in the subcutaneous implantation procedure.
 - c. Administering healthcare professional has completed requisite procedural training provided by product manufacturer.
5. Approval.
 - a. Initial: six months.
 - b. Re-approval: six months [must meet one listed below]:
 - Increase in pain free time during sun exposure.
 - Reduction in the number of phototoxic reactions from baseline.
 - Decrease in severity of phototoxic reactions from baseline.
